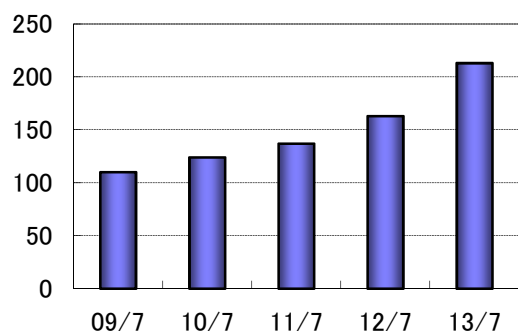
設備投資額 Capital expenditures



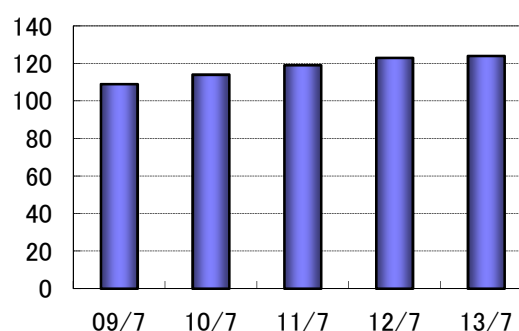

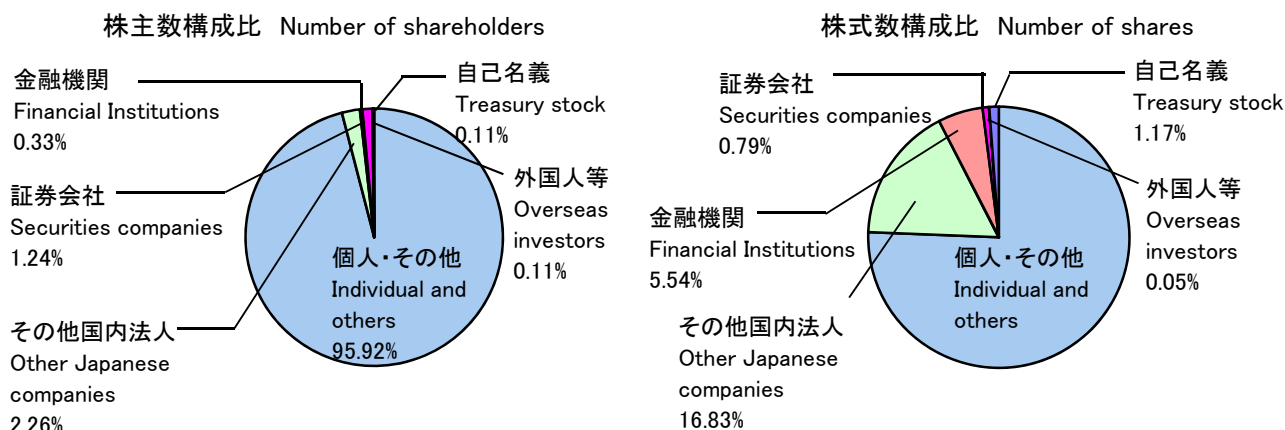

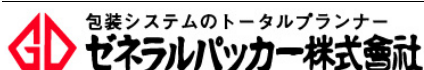
