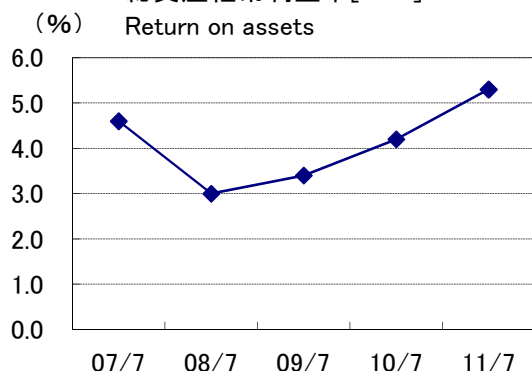
売上高営業利益率



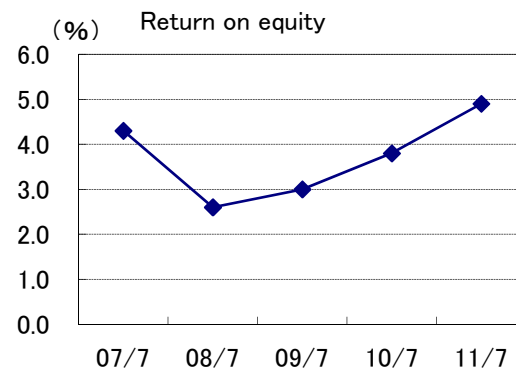
売上高経常利益率



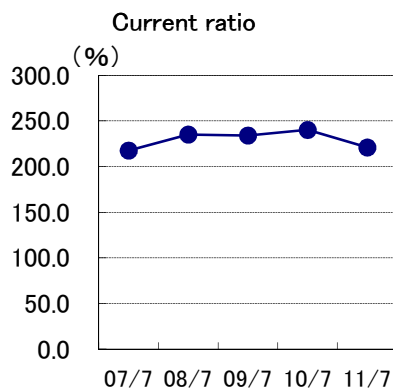
総資産経常利益率[ROA]



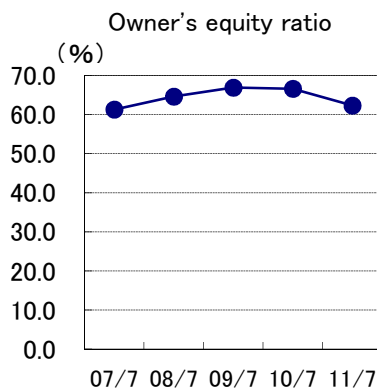

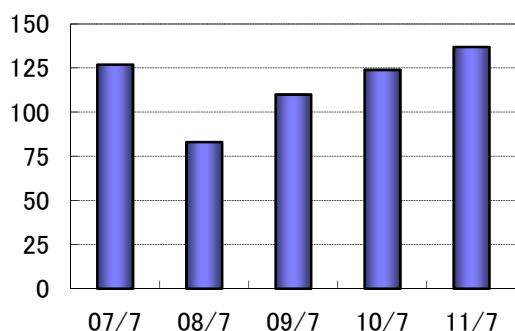

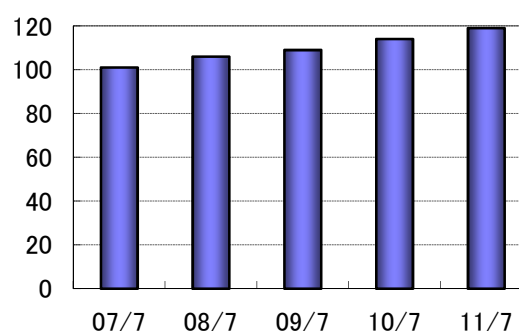

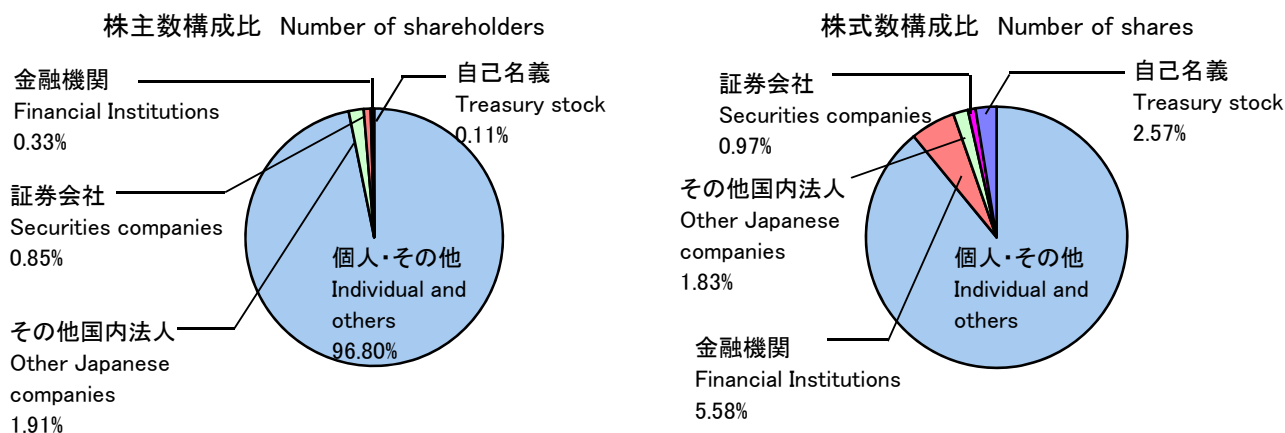
